### TUITION

The school year is from the first day of school to the last day of school, as noted on the Sacred Heart School calendar. You agree to pay tuition and fees for your child for the entire *School Year* (or, if your child is starting after the *First Day of School*, from the starting date) through the *Last Day of school*, subject to the Early Withdrawal guideline listed below. You may pay tuition by selecting an installment plan—as specified by SMART Tuition.

### EARLY WITHDRAWAL

Withdrawal from Sacred Heart School during the school year requires at least 30 school days notice. You must continue tuition payments for attendance through the date which is 30 school-days after our receipt of your withdrawal notice. Early withdrawal is subject to a \$100 consumable book fee.

### TUITION DUE / LATE CHARGES

Tuition and fee payments are due and payable at the times stated on the Fee Schedule through SMART Tuition. Tuition and fees are considered delinquent on the day following the due date. A late payment fee will be charged by SMART Tuition if payment is not received by the due date. If tuition and any other outstanding charges are not paid for the current half-year by December, attendance at Sacred Heart School will not be permitted until tuition is paid in full for the past due amount and the current period. Pre-K students will not be permitted to attend Sacred Heart School if tuition is one-month delinquent.

### RENEWAL

Registration at Sacred Heart School is on a school-year basis. Your child will not be guaranteed a reservation for the following school year, unless you consent to a new tuition agreement with the School for that school year and pay all applicable tuition and fees in full.
